How to Get a Trial Date When a Response Had Been Filed in Your Case (Unlawful Detainer)

Step 1	Complete the following forms in blue or black ink: Request to Set Date for Trial-Unlawful Detainer (UD-150)
Step 2	Service on the Other Party: Make one copy of your completed and unfiled UD-150, including an unsigned copy of the proof of service. Then have someone who is 18 or older, NOT YOU, mail the copy to the other party.
	Then have the server complete the Proof of Service by Mail on page 2 of UD-150.
Step 3	Copies: Make a copy of form FL-150 with the completed Proof of Service by Mail.
Step 4	File: Turn in the original and copy to the Clerk's office located at: 191 North First Street, San Jose, CA 95113 The Clerk's Office opens at 8:30am Monday-Friday, closing times are subject to change, visit www.scscourt.org or call 408-882-2100 for current office hours. The clerk will keep the original and return your copy. Keep the copy for your record.
Step 5	Trial Date: The Court will send you the trial date in the mail.
Step 6	Go to your Court hearing: Go to your trial date prepared to present your case.
