## 2024-2025 Civil Grand Jury Demographic Data

**Summary:** The Court received 112 new applications to serve on the 2024-2025 Civil Grand Jury. Of those, six individuals were not qualified to serve and have been omitted from the data below pursuant to California Rule of Court 10.625(a)(4).

Two individuals and one alternate from the 2023-2024 Civil Grand Jury were nominated by the judicial officers of the Superior Court to serve as prospective regular grand jurors. These three carry-over jurors were included in the data below according to California Rule of Court 10.625(b)(2).

Of all 109 prospective regular grand jurors, two individuals served one previous term as a civil grand juror in Santa Clara County and one individual served two previous years as a civil grand juror in Santa Clara County. In addition, one individual served one term as an alternate in Santa Clara County and one individual served as a civil grand jury in another jurisdiction in the past.
