\*\***Finding 1a:** The working relationships among Councilmembers and the Mayor are broken.

**Recommendation 1a:** The City should hire a conflict resolution professional and adopt robust resolution training strategies. This recommendation should be implemented by October 1, 2024.

\*\***Finding 1b**: Some Councilmembers do not adhere to the City's adopted ethical and behavioral standards while conduction City business on the dais.

\*\***Recommendation 1h:** Even though Mayor Gillmor has shown appropriate meeting decorum, the Mayor should attend one-on-one conflict resolution training to learn how to work effectively in the current challenging Council meeting environment. Additionally, as the meeting chair, the Mayor should receive training to facilitate effective meeting flow. This recommendation should be implemented by October 1, 2024.
