***Purpose and Terms of Hold:*** This PC § 3452 Hold is initiated to place the arrestee in detention for the purpose of bringing the arrestee before the Sonoma County Probation Department (in its capacity as the PCS Supervising County Agency designated under Penal Code § 3451(a)), or an out-of-county supervising agency so designated, pursuant to the County's postrelease strategy and Penal Code §§ 3454, 3455(a)(4).

**This Hold is limited to a period of time not to exceed 48 hours, excluding weekends and County holidays, from the time of booking.** Flash incarceration under Penal Code § 3454 for a period of time exceeding the Hold, up to a consecutive period of ten days, is permitted only upon the express authorization by the Sonoma County Probation Department or designated out-of-county supervising agency, which authorization supercedes this Hold.

***Review by PCS Supervising Agency:*** Upon review of the Hold, the Sonoma County Probation Department or designated out-of-county supervising agency authorizes the Sonoma County Sheriff's Office to take one of the following actions:

- Drop Hold; release person from custody.
- Flash Incarceration authorized (per separate Authorization form); maintain custody.
