Constitution Day, Monday, September 18, 2023



Constitution Day (or Citizenship Day) is an American federal observance that recognizes the ratification of the United States Constitution and those who have become U.S. citizens. It is nationally observed on September 17, the day the U.S. Constitutional Convention signed the Constitution in 1787.

In celebration of the 236th anniversary of the Constitution on September 17, 2023, judges will reach students from across the county, either in person or virtually. Additionally, the Court has created a <u>Constitution Day presentation</u> available on YouTube.

Educators' Day with the Bench October 26, 2023

Educators Day is an annual event hosted by the Superior Court which focuses on legal issues of joint concern to our courts and our schools. The program is a one day event intended for High School and Middle School administrators. Previous topics include gang-involved youth, chronic absenteeism, mandatory reporting, Juvenile Dependency and Juvenile Justice involved youth.

In 2022, this event returned to an in person format and included educators from across the County to engage in discussions about mental health and wellness.

• Court Visits:

- o The Court welcomes community organizations and educational institutions to participate in organized visits. Court visits are tailored to the age, educational purpose and time allocations of the individual organizations.
- Generally, all court proceedings are open to the public. Those wishing to visit a courthouse and plan to attend as audience members do not need to schedule in advance and are encouraged to attend independently.

Mock Trial:

- o A "mock trial" is a simulation of a court trial. Our program offers students the opportunity to participate in a rehearsed, interactive fictional trial so they can learn firsthand the Court's role in the judicial branch.
- Students must prepare and rehearse roles before actual mock trial in the courthouse.
