RESOLUTION RE REVISIONS TO FORMS
RELATED TO FAMILY JUSTICE CENTER

WHEREAS, Rule IV(G) of the Internal Policies of the Superior Court of California, County of Santa Clara provides that all actions to amend, adopt, suspend or repeal a Local Rule of Court require a majority vote of the sitting judges of the Court at a regularly scheduled, noticed and agendized Bench Meeting; and

WHEREAS, adopting revisions to local forms FM-1010, FM-1016, FM-1025, FM-1036, FM-1050, FM-1051, FM-1067, FM-1068, JV-2021 and JV-2029 to delete references to the Sunnyvale, Morgan Hill, Notre Dame, Terraine and Park Avenue courthouse locations and add references to the Family Justice Center Courthouse, effective August 1, 2016, will permit the Court to provide timely and accurate information to attorneys and litigants in Santa Clara.

WHEREAS, in order for the Presiding Judge to carry out her responsibilities under California Rules of Court, Rule 10.603, including ensuring the effective management and administration of the Court consistent with rules adopted by the Court, she may be required to revise some Local Rules regarding the Court’s business on an expedited basis; and

WHEREAS, the Presiding Judge has requested a majority of the sitting judges of the Court at a regularly scheduled, noticed and agendized Bench Meeting to authorize her, by General Order and only to ensure the effective management and administration of the Court

1 consistent with rules adopted by the Court, to revise local forms FM-1010, FM-1016, FM-1025,
2 FM-1036, FM-1050, FM-1051, FM-1067, FM-1068, JV-2021 and JV-2029 to delete references
3 to the Sunnyvale, Morgan Hill, Notre Dame, Terraine and Park Avenue courthouse locations
4 and add references to the Family Justice Center Courthouse, effective August 1, 2016, as
5 approved by the Executive Committee;

6 NOW, THEREFORE, the majority of the sitting judges of the Court at a regularly
7 scheduled, noticed and agendized Bench Meeting hereby authorize the Presiding Judge, by
8 General Order and only to ensure the effective management and administration of the Court
9 consistent with rules adopted by the Court, to revise local forms FM-1010, FM-1016, FM-1025,
10 FM-1036, FM-1050, FM-1051, FM-1067, FM-1068, JV-2021 and JV-2029 to delete references
11 to the Sunnyvale, Morgan Hill, Notre Dame, Terraine and Park Avenue courthouse locations
12 and add references to the Family Justice Center Courthouse, effective August 1, 2016, as
13 approved by the Executive Committee.

14 This resolution and the General Order regarding Mandatory Electronic Filing shall be
15 posted on the Court's website and distributed to the Santa Clara County Bar Association,
16 Attorney General, Santa Clara County Counsel and Silicon Valley Bar Association.


GENERAL ORDER
