# Notice to Appear

- · When filed in lieu of verified complaint is a complaint to which a plea may be entered(VC40513) (People v Barron)
- PC1024-if defendant fails to enter a plea enter a not guilty plea for him/her with time not waived and set trial date
- · Electronic citations

#### **Notices to Correct**

- VC40610-can be issued for registration, license and mechanical violations unless officer finds fraud or persistent neglect, an immediately safety hazard, or violator does not agree to or cannot promptly correct the violation
- VC40416-misdemeanor charge for failing to provide proof of correction
- Insurance violations are correctable with proof of insurance on the date of the citation-cannot be signed off -must show proof in clerk's office or court

#### Misdemeanors

- Punishable by jail (six months and/or \$1000 fine)
- · Right to court appointed counsel if eligible
- Right to judge after arraignment
- · Possible immigration consequences
- No right to trial by written declaration
- · Not eligible for traffic school
- Can reduce some to infractions with consent of defendant PC 17 and PC 19.8
- · Right to appeal within 30 days

#### Infractions

- Punishable by fine only (Generally maximum is \$250)
- · No right to court appointed counsel
- No right to a jury trial
- Trial by written declaration is OK for most VC violations if made prior to due date (VC 40902)
- Traffic school allowed
- · Right to appeal within 30 days
- Generally all provisions applicable to misdemeanors apply to infractions with above exceptions

#### Juveniles

- Traffic infraction matters are handled in Traffic Court
- Parents are not required to be present
- · Bench warrants cannot be issued
- Convictions for drug or alcohol violations result in (1) year license suspension (under 21)
- Allowed fewer number of points before DMV takes action

# Failure to Appear at Arraignment

- · Bail can be forfeited
- Civil Assessment (PC 1214.1)
   (use this option for all that are eligible)
- Trial by Declaration pursuant to VC 40903
- Trial in absentia (PC 1043)
- Bench warrant issued with increased bail (Not too common anymore)

#### **Trials**

- Call "roll call" from the calendar & deal with continuances and other requests
- Arraignment/Trials-advise of basic rights
- · Advise of procedures (optional)
- Swear in witnesses
- Standard of proof-reasonable doubt
- · Not Guilty order Bail Exoneration
- Guilty Fine or Traffic School (Court must consider TS if requested People v. Wozniak)

## **Speeding Violations**

- VC 22349 (a)-Exceeding the Max Speed
- VC 22350 –Unsafe Speed
- · Different Elements and Defenses
- Citation must have: approximate speed, prima facie or maximum speed and any other speed alleged to have been exceeded

### **Pacing**

- Bumper Pace, Definition, Distance and Duration
- Speedometer Calibration
- People v. Lowe (2002) 105 Cal App. 4<sup>th</sup> Supp. 1
- · No Survey required

#### Radar/Lidar Citations

- Speed Trap Rules-VC 40802
- Does not apply to maximum speed violations, school zones, local roads
- Prima facie speed must be justified by a traffic and engineering survey
- 85<sup>th</sup> percentile-round up or down and can be 5 miles below if justified
- · Officer-post training required
- · Meets or exceeds NTHSA standards
- Unit independently calibrated within 3 years

# Possible Grounds for Appeal · Judge as Prosecutor Refusal of Cross Examination Refusal to allow relevant testimony Discovery Issues • Evidence does not support verdict • Guilty verdict in open court (submission) • Improper use of Speed Trap evidence · County Seat **Appeals** · Notice must be filed within 30 days · Defendant must submit Proposed Statement on Appeal · Court has duty to settle the record • Use electronic recording and transcript Traffic School • Procedures and Eligibility CRC 4.104 • People v. Wozniak (1987) 197 Cal.App.3d Supp. 43 , 243 Cal.Rptr. 686 -- Court cannot have "policy" to deny after conviction - Benefit to Defendant - No arbitrary refusal - No reason for denial need be put on record

# Traffic School Eligibility · Non-commercial license One pointer • 18 month requirement (date of citation to date of citation) • 25mph over speed limit (15mph over for juveniles) · No alcohol related offenses Judge has discretion Imposition of Sentence People v. High (2004)119 CA4th 1192 Must specify fines, assessments and fees on the record **Fines** Includes: □Base Bail □Penalty Assessments □Fees □Reasonable □Community Service in lieu of fine

#### Base Bail

- Each offense has a set base bail amount that can be used as a guideline for the fine-shown on the convelope
- VC 42001 sets general maximum fines
  - Up to \$100 first offense
  - Up to \$200-2<sup>nd</sup> offense within (1) year
  - Up to \$250-3<sup>rd</sup> or subsequent offense within (1) year

#### **Assessments**

- Mandatory to include penalty assessment to base bail
- Amount of assessment depends on date of offense-goes from 170% to current 310%

#### Fees

- Court Operations Penalty Assessment-\$40/conviction
- \$10-Prior Search Fee
- \$1-Night Court Fee
- \$49-Traffic School Fee
- \$30 -Fine Payment Extension Fee
- \$24-Traffic School Completion Extension
- \$10-Hold Fee for FTAs and FTPs
- \$15-Warrant Fee for FTAs and FTPS
- 1/1/09 new fees (\$35 conviction fee per infraction \$30 per misdemeanor

## Standard Red Light Fine

- \$100 Base fine
- \$300 or \$310 Penalty Assessment
- \$10 Prior Search Fee
- \$35 ICIN Fee
- \$40 Court Operations Penalty Assessment
- \$1 Night Court Fee
- \$4 EMS Fee
- Total Fine=\$490 or \$500 (plus \$30 for extension to pay)
- Traffic School = \$529 (no prior search fee but \$49 traffic school fee) Use the chart
