Call to Order & Introductions: Chair Betts called the meeting to order at 12:15pm.

Agenda Approval: The agenda was approved by all Commissioners present.

Swearing In: Honorable L. Michael Clark administered the oath of office to Nora Manchester as Juvenile Justice Commissioner in the County of Santa Clara, for a term ending in 2027.

Public Comments/Oral Petitions: None.

Approval of Minutes: November 7, 2023 Minutes approved by all Commissioners present.

REPORTS

PRESENTATION: BILL WILSON CENTER (Josh Selo)

- BWC supports and strengthens the community by serving youth and families through counseling, housing, education, and advocacy.
- BWC is working to prevent poverty in the next generation by connecting youth and families to education, employment, housing, and positive relationships that will end youth and family homelessness.
- BWC values: belonging, collaboration, compassion, impact, integrity, learning, perseverance.
- Founded in 1973 (celebrating 50 years of service in 2023!)
- \$35 million operating budget, 203 full-time staff
- Program focus: housing, foster care services, counseling & behavioral health, supportive & prevention services, advocacy.
- Key Accomplishments 2022-2023
 - o 4,723 clients served
 - o 900+ beds of housing made available each night
 - o 19,213 counseling sessions provided
 - o 1,492 young adults received housing services
- Safety Net Shelter
 - o For youth aged 12-17
 - o 20 beds; average stay 2-4 weeks
 - o Array of services provided: counseling, medical, education
 - o 89% reunification with family and/or stable placement
 - o Largest referral sources: parents/guardian, law enforcement, self-referral
 - o Served 162 clients in 2022-2023
- Transitional Housing Placement Program (THPP)
 - o For youth aged 16-18 involved in dependency

- o Serves up to 13 youth at one time; housing for 2 years
- Wraparound services, including case management, life skills coaching, medical and mental health care, educational planning, career development, and personal finance.
 Served 23 youth in 2022-2023 (17% had some involvement with juvenile justice)
- o Served 23 youth in 2022-2023 (17% had some involvement with juveni Transitional Housing Placement Non Minor Dependents (THP-NMD)
 - o For youth aged 18-21 in extended dependency
 - o Serves up to 25 young adults at a time, housing for up to 36 months
 - o Wraparound services, including case management, crisis intervention, life skills coaching, medical and mental health care, educational planning, career development, substance use education/treatment, parenting skills, and personal finance.
 - o Served 42 youth in 2022-2023 (21% had some involvement with juvenile justice)
- Nisreen Baroudi asked: If law enforcement brings a youth to BWC, does the parent have to consent to them being there?
 - o Josh: No
- Nisreen asked: For the 16-18 year olds, dependents don't need parental consent to be placed at the BWC, but do juvenile justice youth need parental consent?
 - o Josh: I'm not sure, I'll have to check on the answer.
- Commissioner Bellicitti asked: What's the difference between homeless citizens and unhoused citizens?
 - o Josh responded: Homeless vs housing insecurity. Homeless definition means you're sleeping outside. Young people often won't be classified as literally homeless if they're couch surfing, because they technically have a roof over their head.
- Commissioner Ghoshal asked: Is capacity an issue for THP?
 - o Josh responded: The issue lately has been staffing; we don't have enough staff to operate the program.
 - o Dev asked: If staffing is a constraint to satisfy the demand, do you keep track of all the requests you can't fulfill?
 - o Josh: Yes, we keep track.

Chair's Report: Chair Betts reported on the following:

- Just completed LEA report.
- Currently working on inspections of: The Ranch, and Welcoming Center.
- A few commissioners visited the Secure Youth Treatment Facility at the Ranch.

Presiding Judge: Honorable L. Michael Clark reported on the following:

- As of Dec 1st -- 1,052 youth with active cases in Juvenile Probation.
- As of Dec 1st -- 71 boys, 5 girls in Juvenile Hall
- As of Dec $1^{st} 34$ youth at the Ranch
- 2 days in Nov with only 1 girl in Juvenile Hall
- Superior Court has started recruitment for the Civil Grand Jury
- What are your plans for 2024?—Turn over the role of Juvenile Presiding Judge to Judge Franco.

• Planning to take over Juvenile Presiding Judge in 2024.

• What are your plans for 2024? – Transitioning new CEO in the new year.

• A few youth at Juvenile Hall have completed Associate's degrees.

- Continue to provide students with Fork Lift Certification program.

- Continue to provide students with the opportunity to take college courses.

- January is Human Trafficking Awareness month
- Having a presenter come to speak with boys about male trafficking.
- Training coming up about interviewing males for disclosures.

- Conversation surrounding DFCS Strategic Framework has been sent to JJC and CAPC.
- Awaiting to hear if DFCS will be impacted by the budget cut.

Probation Department: Dustin Eng reported on the following:

- Offering new program: Healthy Sexual Behavior
- Highlight: a Probation Officer was able to supply a youth's mother with narcan, and she used it the same day to save the youth's life.
- Educational Services unit participated in Late Night Gym Night and Dia de los Muertos event.
- Officers participated in career day at Apollo High School.

- 4 youth from SYTF program visited SJSU to give presentation on topics including perception in the workplace, anxiety, code switching, and love languages.
