SANTA CLARA COUNTY JUVENILE JUSTICE COMMISSION FY 2012-2013 ANNUAL REPORT

The Juvenile Justice Commission of Santa Clara County is a state-mandated, courtappointed authority. The broad purpose of the Commission is to inquire into the administration of the juvenile court law in the county. The Commission is dedicated to the promotion of an effective juvenile justice system operated in an environment of credibility, dignity, fairness, and respect for the youth of Santa Clara County.

COMMISSION MEMBERSHIP

Pursuant to California Welfare and Institutions Code 225, the Juvenile Justice Commission shall consist of 15 volunteer citizens, two of which shall be youth Commissioners who are persons between 14 and 21 years of age. Commissioners must also be residents of Santa Clara County. At the end of the fiscal year 2012-2013, the Commission was composed of the following Commissioners:

Commissioners are sworn to four-year terms, except for youth Commissioners who are sworn to two-year terms. Over the past year, two Commissioners resigned, Ken Nelson and Bob Nunez.

The membership of the Commission should be representative of the community and should include representation from different geographical areas of the County. In order to achieve such diversity, the Commission has reached out to various organizations throughout the county and has promoted the Commission.

STANDING COMMITTEES ASISGNMENTS AND ANNUAL FACILITY INSPECTIONS

The Commission conducts annual inspections of the County's juvenile detention facilities and at least one group home. All Commissioners are required to participate in these inspections and to document their findings in written reports, which are sent to the Santa Clara County Board of Supervisors. At the beginning of each fiscal year, the Executive Committee, which is made up of the Chair, Vice Chair, Secretary and Past Chair, select the members of the inspection teams. As a result of Commissioner resignations, or availability, or issues that required immediate attention, committee assignments and facilities inspection dates were modified during the fiscal year.

Facilities Inspection Report Status:

The Juvenile Hall Inspection Committee began its inspection in Jan 2013, and the Commission approved its final report in April 2013.

The Children's Receiving, Assessment and Intake Center Committee began its inspection in January of 2013 and the Commission approved the first report in January 2013. Because of the serious nature of the issues uncovered in the first report, the Commission re-inspected the Children's Receiving, Assessment and Inspection Center and approved an updated report in March 2013.

The Group Home Inspection Committee began its inspection of the Kooser House Adolescent Group Home in May 2013 and the Commission approved the final report on July 2013.

The James Ranch Inspection Committee began its inspection in April 2013 and the Commission approved the final report in July 2013.

The Law Enforcement Facilities Committee surveyed all the law enforcement operations in Santa Clara County and determined that no juveniles had been held more than 24 hours as reported to the Juvenile Court presiding judge in June 2013.

GOALS AND OBJECTIVES

The following is a list of goals and objectives created by the Commission for the 2012-2013 fiscal year. The status of these goals and objectives is as follows:

1. Complete all scheduled inspections by June 30th, 2013.

Two of the annual inspections were not approved until July 2013. This was the result of a late start to one of the inspections and the second was due to the resignation of the inspection team leader. The substantial effort on the part of the Commission with its focus on the Receiving, Assessment and Intake Center issues helped contribute to two of the reports completion being delayed.

2. Publish a status report on all inspection recommendations no later than 180 days from the reports publication.

The Commission needs to develop a more structured approach to this process in order to meet its goal.

3. Conduct training for all new Commissioners within 60 days of appointment Training was conducted for new Commissioners in January 2013 by Judge Tondreau, the Presiding Judge Juvenile Court, and Jenny Lam, the Commission's Counsel.

4. Monitor and report to the Juvenile Justice Commission all Incident Reports (IRs) filed at all detention facilities inspected during the year.

Two Commissioners visit the Juvenile Hall monthly and report to the full Commission at the monthly executive session the results of their review.

5. Schedule regular quarterly meetings with the Board of Supervisors president to review Commission activities.

Commission members met once with the Board of Supervisors President or their policy aides and with other Supervisors to discuss various juvenile justice issues during the 2012-2013 fiscal year. In addition, the Commission addressed the Children's, Seniors and Families Committee, and the Public Safety and Justice Committee.

6. Schedule presentations to the Commission on juvenile justice issues The Commission had two presentations during the fiscal year that included representatives from the District Attorney and Juvenile Probation Department.

COMMUNICATIONS WITH THE PUBLIC

In a continuing effort to make the Commission accessible to juvenile justice partners, the general public, youth served within the juvenile justice system, and the parents and relatives of those minors, the Commission has established several means to communicate with the public and disseminate information. TRAINING

All newly appointed Commissioners attend a three-hour orientation and training session. The Presiding Judge of the Juvenile Court and the Commission's County Counsel attend this meeting and provide an overview and description of the Commission's responsibilities. Members of the executive team reviewed the Commission's procedures in a separate training session with Commission members. Commission members also attended Court sponsored training sessions throughout the year.
