SANTA CLARA COUNTY JUVENILE JUSTICE COMMISSION FY 2015-2017 ANNUAL REPORT

The Juvenile Justice Commission of Santa Clara County is a state-mandated, court-appointed authority. The broad purpose of the Commission is to inquire into the administration of the juvenile court law in the County. The Commission is dedicated to the promotion of an effective juvenile justice system operated in an environment of credibility, dignity, fairness, and respect for the youth of Santa Clara County.

COMMISSION MEMBERSHIP

Pursuant to California Welfare and Institutions Code 225, the Juvenile Justice Commission shall consist of up to 15 volunteer citizens, at least two of which shall be youth Commissioners, who are persons between 14 and 21 years of age. Commissioners must be residents of Santa Clara County. At the end of the fiscal years 2015-2017, the Commission was composed of the following Commissioners:

GOALS AND OBJECTIVES

The Santa Clara County Juvenile Justice Commission established the following Goals and Objectives for 2015-2017:

- 1. Complete all scheduled inspections by June 30, 2016 and June 30, 2017.
 - All required inspections were completed.
- 2. Conduct training for all new Commissioners within 60 days of appointment.
 - This was done.
- 3. Monitor monthly and report to the Juvenile Justice Commission all Incident Reports (IR's) filed at all detention facilities inspected during the year.
 - Monitoring occurs monthly, and the Commission continues to receive a monthly salient features report from the Probation Department.
- 4. Complete Court User Satisfaction survey and report before the end of 2016.
 - This survey was begun in July, 2014 and the team published an interim report in July, 2015. The final report was published in July, 2016.
- 5. Schedule regular reviews with the Board of Supervisors President to review Commission activities.
 - The Commission Executive team met with the Board of Supervisors President.
- 6. Schedule presentations to the Commission on juvenile justice issues.
 - The list of presentations is outlined below.

INSPECTION REPORTS:

The Commission undertook a Court User Satisfaction survey of the Juvenile Justice Court in July 2014. This ambitious project continued throughout the entire fiscal year and the final report was published in July, 2016.

The James Ranch Inspection report were published in August, 2015, September, 2016, and June, 2017.

The Juvenile Hall Inspection reports were published in April 2016 and March, 2017.

The Commission inspects all the Law Enforcement Agencies (LEA) that detained minors for any length of time during the preceding year. In 2015, the Commission inspected seven LEA, which the State reported as having held youth; in 2016, the Commission inspected eight LEA. The reports were published in February, 2016 and December, 2016.
