DEPENDENCY ADVOCACY CENTER IN
ALL DEPENDENCY CASES IN WHICH
THE COURT HAS PREVIOUSLY
APPOINTED SANTA CLARA JUVENILE
DEFENDERS TO REPRESENT PARENTS,
LEGAL GUARDIANS, DE FACTO
PARENTS, OR CHILDREN WHEN A
CONFLICT HAS BEEN DECLARED**

TO: ALL PARTIES IN DEPENDENCY CASES IN WHICH THE SUPERIOR COURT HAS PREVIOUSLY APPOINTED SANTA CLARA JUVENILE DEFENDERS TO REPRESENT PARENTS, LEGAL GUARDIANS, DE FACTO PARENTS, OR CHILDREN WHEN THE DISTRICT ATTORNEY HAS DECLARED A CONFLICT.

GOOD CAUSE APPEARING,

IT IS ORDERED that, effective October 1, 2008, Dependency Advocacy Center, and its respective offices, is hereby substituted for Santa Clara Juvenile Defenders, and its respective offices, in representing parents, legal guardians, or de facto parents in dependency cases as well as children in dependency cases where the District Attorney has declared a conflict.

IT IS FURTHER ORDERED that, effective October 1, 2008, all papers and documents in dependency cases in which Dependency Legal Services has appeared shall be served on Family Legal Advocates as follows: Family Legal Advocates, 31 North Second, Suite 335, San Jose, CA 95113

IT IS FURTHER ORDERED that, effective October 1, 2008, all papers and documents in dependency cases in which Associate Dependency Attorneys has appeared shall be served on

Office of Dependency Counsel as follows: Office of Dependency Counsel, 31 North Second,
Suite 330, San Jose, CA 95113.

IT IS FURTHER ORDERED that, effective October 1, 2008, all papers and documents
in dependency cases in which Preeti Mishra, Esq., has individually appeared shall be served on
Catherine Nguyen, Esq. as follows: Law Office of Catherine Nguyen, 31 North Second, Suite
325A, San Jose, CA 95113.

IT IS FURTHER ORDERED that, effective October 1, 2008, any additional
substitutions of attorney not specifically covered by this Standing Order will be made on the
record or through other means, as approved by the Court.
