# SANTA CLARA COUNTY SECURE YOUTH TREATMENT FACILITY (SYTF) INSPECITION REPORT (Commissioner Dev Ghoshal)

- Conducted inspection over 3 months.
- This was the third inspection of SYTF by the JJC.
  - o This inspection included the Learning Independence for Tomorrow (LIFT) program as well. The LIFT program serves as a step-down program from Juvenile Hall.
- The JJC found:
  - SYTF and LIFT units were well supervised and thoughtfully managed while maintaining compliance with regulations.
  - o SYTF admin continue to add new programs and skills for the youth.
  - o Some SYTF youth have already started transitioning to colleges or trades.
  - o LIFT program allows youth to make outside visits for family, educational, or employment reasons.
  - O Youth provided positive feedback regarding staff enthusiasm and program flexibility.
- The JJC found concerns regarding:
  - o Employment options, transportation flexibility, and some policies that need to be finalized.
  - o Ensuring sufficient time for creating a re-entry plan for youth.
- Next steps: JJC will review responses received.
