REPORTS

PRESENTATION: Adolescent Residential Substance Treatment (Rachel Talamantez, Vanessa Cornejo, Eric Forestal)

- The Camp Recovery Center
 - o Started in 1984
 - o 25 acre facility in the Santa Cruz Mountains
 - o Highly structured program, rich in evidence based treatment modalities
- Philosophy: "Recovery means life"
- Program Overview:
 - For everyone—74 bed residential facility, medically monitored detox, withdrawal management, SUD & co-occurring tracks, family involvement & support, psychiatry & med management, MAT, CBT, DBT, ACT, CPT, EMDR, holistic care, discharge planning, alumni program.
 - o For adults—PHP/IOP in Scotts Valley & San Jose, veterans services.
 - o For adolescents—accredited on-site high school, experiential treatment modalities.
- Detoxification
 - o 24/7 nursing care
 - Withdrawal management
 - o Medication assisted treatment
 - o Individualized management & care
 - o General medical & nursing services
 - Client focused biopsychosocial care
- Substance Use Disorder Track (SUD)
 - o Individual/group sessions with a counselor weekly

- o Individualized treatment planning
- o Exposure & involvement with the 12-Step philosophy
- Sober recreational activities
- o Continuing Care and Relapse Prevention Planning
- o Holistic approach (body, mind, and spirit)
- o Fully accredited academic program
- o 6 hours of evidence-based curriculum daily
- Co-Occurring Disorder Track (COD)
 - o Individualized sessions 2x weekly with master-level therapist
 - o Psychiatric evaluation
 - o Weekly psychiatric follow up
 - Medication monitoring
 - o COD specific groups 4x weekly
 - o Crisis management support
- Adolescent Experiential Recovery
 - o Surf & water sports modality, equine assisted psychotherapy, goat assisted therapy
- Referral Process
 - Step 1: Youth can call the BHSD Call Center at 1-800-704-0900 for a referral to SUTS outpatient services.
 - Step 2: Once a youth is deemed in need of residential treatment, the SUTS outpatient counselor screens youth using the Authorization for Level of Care (ALOC) and submits request to BHSD Utilization Management (UM) team.
 - Step 3: Referring counselor will hear back from BHSD UM within 24 hours as to whether the ALOC has been approved, denied, or rejected.
 - Step 4: BHSD UM will send a copy of the approved ALOC, Synopsis, and ROIs to the The Camp.
 - o Step 5: The Camp will connect with the youth and guardian/family for admission.
- Chair Betts asked: Does the adolescent program include 12-Step as well?
 - Eric responded: Yes. We are mandated to provide 6 hours of evidence based practice, but we provide many supplemental programs.
- Chair Betts asked: Do you expect youth to get a sponsor and go to meetings after The Camp?
 - o Eric responded: No, it's voluntary and whatever works best for the youth.
- Chair Betts asked: How do you engage families?
 - o Eric responded: We offer visitation biweekly facilitated by a counselor. We also offer virtual family planning services on Saturday.
- Commissioner BurtonBurke asked: Are the youth housed separate from adults?
 - o Eric responded: Yes, completely separate. They don't interact, or eat, or program together at all.
