# PROBATION DEPARTMENT'S JUVENILE DATA DASHBOARD (Kimberly D'zatko, Lakshmi Musunuri)

- Probation gave a demonstration on how to access data and reports from the Probation website.
- From the home page, click on the "data & reports" tab.
- Click on the different hyperlinks to access specific data dashboards.
  - o There will be instructions on how to navigate the data on each dashboard.
- Data is filtered by year.
  - o Select the year for which data you would like to see.
- Dashboards are accessible to the public.

#### **Chair's Report:** Chair Betts reported on the following:

- Heather Angove and Rayan Sengupta have resigned from the JJC.
- Michelle Wu has joined the JJC as a Youth Commissioner.
- Wrapping up SYTF/LIFT inspection and beginning Law Enforcement Agency inspection.

#### **Presiding Judge:** Judge Franco reported on the following:

- Judges will begin working on Juvenile Hall and SYTF inspection report.
- Judicial assignments for Juvenile will be confirmed in November and will likely stay the same.
- Commissioner asked: What is your inspection comprised of?
  - o Judge Franco: We start with the intake process, and we ask specific questions as we walk through the full tour. We look to see how the units operate and if anything has changed.

Judges will sometimes interview one or two youth to include their perspective. The Judge's report is not usually as detailed as the JJC report.

**Alternate Defender's Office:** No one present to report.

**Independent Defender's Office:** Lana Kreidie had nothing new to report.

**Legal Advocates for Children & Youth (LACY):** No one present to report.

**Dependency Advocacy Center (DAC):** No one present to report.

Conflict Resolution Services (formerly OMOS): Ruth Maurice had nothing new to report.

Alternative Schools Department: Eugene Santillan reported on the following:

- Met with commissioners for SYTF inspection.
- Osborne students will have access to new CTE program called Roots of Success.
  - o Focused on exposing students to environmental issues or green careers.
  - o Upon completion of the program, students will receive certificate as an Environmental Specialist from the State of California.
- Working with county partners to build programming for the Welcome Center.

Mark Camilleri reported on the following:

- Purchased two new machines for the construction trades program.
- Programs focus on career readiness by preparing students to operate machinery that is actually used on the job site.
- Relocated music room to the old library.

Trina Gauthier reported on the following for Juvenile Hall:

- 4 SYTF youth were certified as Peer Health Educators.
  - o These youth facilitated a 6 week curriculum to the peers in their units.
- Hired new Supervising Group Counselor.
- Organized a BBQ fundraiser to raise money for holiday celebrations and cultural events for the youth.
- Supervisors and Managers will be holding staff appreciation event this month.
- Preparing for inspection visit next month.

Elsa Jennings reported on the following for the Ranch:

- Had new Youth Center grand opening.
- SYTF boys took a field trip to Alcatraz Island and Big Basin State Park.
- Several youth in the SYTF program are employed.
- SYTF girls participated in a few community based field trips.

Victoria Contreras-Wolfe reported on the following for services:

• Arranged tours with Santa Clara County Communications dispatch facility.

- Education services unit prepared backpacks filled with supplies for the new school year.
  - o There are still backpacks available for any youth in need.
- Several probation officers were recognized at a provider meeting.
- DIY unit has new supervisor.

**Medical Services:** Lanphuong Le reported on the following:

- Held an event at City Hall displaying art from the Opiate Awareness Project.
