- Through “Envision your Pathway” students beginning a 5-week program to draft their own business plans and learning how to turn vision into viable business.

- Struggling with lots of kids at the sites and finding placements; there are too many kids, all licensed beds are filled. Working on finding appropriate placement for youth; relative placements have increased from 19 to 33.8%

Trina Gauthier reported on the following for Juvenile Hall:

- Population is 56, which include 23 SYTF, 2 females
- Last month 1 youth from SYTF graduated from high school
- 1 youth from SYTF was offered a paid internship through probation

Ashanti Hayes reported on the following for James Ranch:

- Current population at 26; general population of 24. 2 youth in SYTF step down program. Only 1 female due to get out in May
- Programs: Staff continued guest speaker series. Kids are enjoying Beekeeper program
- Started Young Father’s Program. Conducted two meetings with 2 youth and have 3 more upcoming
- For 2026, due to budget constraints, department trying to keep services seamless for clients
