2019 Educators Day At The Court: Court and Community Working Together

Santa Clara Superior Court provides training and discussion for educators in areas that cross over from schools into the justice system

SAN JOSÉ, California (November 7, 2019): On Thursday, October 24, 2019, the Santa Clara Superior Court hosted its sixth annual Educators Day, which brought together approximately 100 superintendents, principals and other educational administrators from around the county to discuss issues at the intersection of education and the law. This year's topics included mandatory reporting, LGBTQ issues, Safe and Healthy Schools: vaping and e-cigarettes, and a panel discussion focused on sexual assault in schools.
