Santa Clara County Civil Grand Jury Discharge and Impanelment Ceremony to Be Held December 16, 2021

The Santa Clara County Superior Court will recognize the outgoing Grand Jury and swear-in the incoming panel

Presiding Judge Theodore C. Zayner announced that the Santa Clara County Superior Court has scheduled the discharge of the 2021 Civil Grand Jury. The Court concluded the annual recruitment of the 2022 Civil Grand Jury and confirmed the impanelment of 19 Civil Grand Jury members to serve for the upcoming calendar year.

As an autonomous body administered by the Santa Clara County Superior Court, the Civil Grand Jury investigates the operations of governmental programs of Santa Clara County, cities, and special districts. Members are recruited by the Court and nominated by Superior Court Judges to serve a one-year term.

"Our incoming and outgoing Grand Jurors have selflessly volunteered their time and efforts to this venerable public service. We appreciate our jurors for their critical look at our local government and for their suggestions as to how our government agencies can better serve the public," said Presiding Judge Theodore C. Zayner. "The Discharge and Impanelment Ceremony is the Court's opportunity to recognize these dedicated public servants for their contributions to the County of Santa Clara."


