The Santa Clara County Superior Court Celebrates the Life and Legacy of Fred T. Korematsu in a Virtual Event Held on Sunday, January 30, 2022

The Santa Clara County Superior Court and Santa Clara University have partnered with community organizations to offer a virtual event on January 30, 2022, which will explore, honor, and celebrate the life and legacy of Fred T. Korematsu.

This online event will offer videos from the community partners, including from the Santa Clara County Superior Court, Santa Clara University, the Korematsu Institute, the Japanese American Museum of San Jose, the Asian Law Alliance, the Council on American-Islamic Relations (CAIR), and the Chief Justice of California, Tani Cantil-Sakauye. Johnny Gogo, Santa Clara County Superior Court; and Zahra Billoo, Executive Director, CAIR San Francisco Bay Area.
