The Honorable Richard J. Loftus, Jr., Presiding Judge of the Superior Court of California, County of Santa Clara, has announced the names of the final candidates for the 2012-2013 Civil Grand Jury. Judge Loftus has selected three members from the 2011-2012 Grand Jury to serve a second term. They are Lyn H. Johnson (Los Gatos), Steven P. McPherson (Los Altos), and Lois G. Weil (Sunnyvale). The new Grand Jury will be selected at the Impanelment Ceremony on June 21, 2012 at 4:00 PM in Department 17, Old Courthouse, 161 North First Street, San Jose, California. Sixteen names will be drawn from the list of 28 finalists, to complete the 19-member panel of the 2012-2013 Civil Grand Jury. They will serve a one-year term, ending June 2013.

Judge Loftus will discharge the 2011-2012 Civil Grand Jury during the first portion of the ceremony. The public is invited to both the Discharge and Impanelment Ceremonies.

The Civil Grand Jury, as part of the judicial branch of government, is an arm of the Superior Court. It serves as the county's civil watchdog and may examine all aspects of county and city government and special districts.
