Procedural Deficiencies

- 1. Examiner cannot locate the original Will or original Codicil lodged in the electronic case system. Were they delivered to the court? Probate C §8200. See Local Probate Rule 4(B) *Original will still not lodged with the Court. Note: If the will is lost, PTR may need to amend petition to probate a lost will instead.
- 2. The Proposed Order for Probate (DE-140) is not in the File and is not pending in E-File.
 *Proposed order submitted. But, Proposed order #5 (re: bond is blank.) There are no bond waivers on file. The Court will ordinarily require a non-resident personal representative to post bond, even if the will waives bond, unless waivers of the bond from all beneficiaries are filed, in which the case the Court, in its sole discretion, may not require a bond. Local Probate Rule 5(B). PEX defers to court whether bond should be set at \$1,050,000.
