3. Petition #3a lists date of death as May 8, **1980**.
4. Petition #2.d(1) selected that bond not required for reasons stated in item #3e. Item #3e selected (3) - All heirs at law are adults and have waived bond. No Waivers of Bond on Judicial Council mandatory form DE-142 attached to petition or filed separately.
 - a. Petitioner is not a nominated executor under the Will. Probate Code §8480/8481
5. Petition #4 – Not selected that decedent's Will does not preclude administration under IAEA. Probate Code §10404
6. Petition #5.a(2)(b) states the decedent's spouse predeceased. But DOD of the spouse is 6/11/2023 in the related case (24PR196803). Current petition #8 lists his DOD as 6/06/2023?
7. Petition #8 – Instructions request listing all persons mentioned in decedent's will, whether living or deceased. Missing mother Dorothy Seymour who is listed as an alternate executor. She is entitled to notice. Probate Code §8110(b)
8. Petition #8 - Date of death for the decedent's daughter is not listed. Pre or post-deceased?
