Having reviewed and considered the request to keep information of a minor confidential, IT IS SO ORDERED:

1. The request to keep information of a minor confidential is **DENIED**.

2. The request to keep information of a minor confidential is **GRANTED IN FULL OR IN PART**.
The court finds all of the following:
 - a. The minor’s right to privacy overcomes the right of public access to the information.
 - b. There is a substantial probability that the minor’s interest will be prejudiced if the information is not kept confidential.
 - c. The order to keep the information confidential is narrowly tailored.
 - d. No less restrictive means exist to protect the minor’s privacy.

3. The court orders that the following information be kept confidential and not viewable by the public, and that this information must be redacted on all subsequent pleadings and orders:
 - a. The minor’s full name.
